Sl. No.	The school is directed to ensure that :
1	Total number of sections shall be restricted to 18 only. School shall not increase the number of sections and any further increase in sections shall be strictly subject to specific approval of the Board on the basis of the request of the school as per affiliation by e law subject to availability of class rooms of greater than 500 sq ft in size and available infrastructure.
2	The land certificate uploaded by the school is issued in year 2019 without having the total period of lease. During the Review Committee, the school has shown only the copy of sale deed between the Private owners and the Kalgighar Trust but no clarity was made on lease period. School is directed to obtain latest land certificate from the competent authority with all details as per Appendix X of circular no 12/2022 and upload the same on SARAS portal within 03 months.
3	The Building safety certificate dated 25.01.2023 as uploaded by the school in Mandatory Public Disclosure link at school website is not as per Appendix XI of the Circular no 12/2022 detailing all complete building details. School is directed to upload the certificate as per appendix XI and on SARAS portal within 03 months.
4	The ramp for the CwSN to access the upper floor has iron rods protruding from supporting pillars, which is not acceptable from safety point of view. School is directed to cover the iron rods with concrete material and upload the compliance on SARAS portal with youtube link within 03 months.

5	Maths lab is not arranged and laid out properly as per Board guidelines vide SoP dated 04.10.2022 (circular no 11/2022). One single central table is temporarily placed for work station which is not sufficient to conduct the module/project work by 40 students at one time. No computer system with net connectivity available for e-learning projects. School should upgrade the Math lab with recommended infrastructure as per Board guidelines and upload the compliance on SARAS portal within 03 months.
6	The urinals in the girls' common toilet are open and separated by a small partition, which is not good and safe from the privacy point of view. School should make the covered urinals in all girls toilets at each floor and upload the compliance with video link on SARAS portal within 03 months.
7	School building is Ground + 1 floor in two blocks but common washrooms and toilets (including for CwSN) are available only at ground floor. School has made no provisions for toilets on first floor. School is directed to construct the common toilets along with CwSN at each floor separately for Boys and girls and upload the compliance with video link on SARAS portal within 03 months.
8	The indoor sports facilities are also to be upgraded with more sports facilities. Only teo indoor sports –carom and chess are available. School is directed to follow the circular no 11/2022 and arrange for more indoor sports infrastructure as per Board guidelines.
9	School shall ensure the mandatory training of its teachers from CBSE, CoE Ajmer and shall upload the compliance on SARAS portal within 03 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Byc -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
